#### 17.3 Kiosk Installation at BCC

It was **AGREED** to request that the installation of the kiosk be delayed until after the building had been open for some months in order that it be established as a Binfield Parish Council facility.

# 17.4 <u>Binfield Community Centre</u>

Councillors considered the need to purchase additional equipment for the centre. It was proposed by Cllr Doyle, seconded by Cllr Leake and **RESOLVED** that £5,000 be allocated from Community Infrastructure Levy funds for these purchases. Cllr Fish was thanked for his offer to review potential purchases of Audio equipment. With regard to the Hiring Agreement, this would be recirculated to Councillors with the suggested amendments by the end of this week so that it can be agreed for use next week for the first hirings of the centre.

#### 17.5 Tennis Court Shrubs

These had recently been considered by the Amenity Committee so it was **AGREED** that this matter be returned to them for consideration.

### 17.6 Binfield Tennis Association Floodlights

Councillors considered the report submitted by the Binfield Tennis Association (BTA). After discussion it was agreed that the Council would not support the installation of floodlights at this time. If the BTA wanted to submit further information in support of this project Councillors would reconsider their position.
